MODIFIED HOMEOWNERSHIP RATE: REGIONAL COMPARISON (2019)

Indianapolis-Carmel-Anderson Metropolitan Statistical Area (MSA)*

The Modified Homeownership Rate is an adjusted rate that examines only homeownership in housing units that are single-family detached units (traditional housing), single-family attached units (e.g., townhomes), 2-unit structures (e.g., duplexes), and 3- or 4-unit structures. This method controls for counties with a higher proportion of multi-family housing structures and provides for a more direct comparison of homeownership rates in housing types that have more traditionally been associated with homeownership.


















POPULATION PROJECTIONS BY RACE & ETHNICITY (2015-2030)

Data Description: Projections are based on a methodology that forecasts a variety of futures based on various economic and ecologic conditions. The data reported here simply reflect the minimum, median and maximum - by race/ethnicity in each year - for both the counts and the percentages of the total. The 2015 data included represent American Community Survey five-year estimates (2011-2015).

INTRA-REGIONAL MIGRATION (2011-2018)

Indianapolis-Carmel-Anderson Metropolitan Statistical Area (MSA)*

County-to-county migration patterns are derived from data published by the Internal Revenue Service (IRS); as such, the data reports "tax returns" and "tax exemptions" rather than households and population. Nevertheless, tax returns and exemptions approximate households and population, respectively.

The data included here show all flows to and from Marion County from the other counties in current configuration of the metropolitan statistical area for the years 2011 through 2018.




