

REQUEST FOR Proposal (RFP)

For: Lawn & Trash Services Indianapolis Neighborhood Housing Partnership®

The Indianapolis Neighborhood Housing Partnership (INHP) is seeking proposals from qualified lawn care professionals (Contractor) to perform lawn care maintenance and trash pickup at INHP-owned properties.

Description of INHP

INHP is a private 501(c)3 and Community Based Development Organization working to increase the overall supply of affordable single- and multi-family housing through investments in development, preservation, lending and grantmaking strategies. This RFP will support its Single-Family Development and Equitable Transit Oriented Development (ETOD) programs in which INHP holds and maintains properties for the purpose of creating affordable housing at each site.

Scope of Work

A. Mowing: Contractor shall mow the grass every fourteen (14) days, or as weather permits, to maintain an appropriate even height for the type of grass during peak mowing season. Mowing outside of the normal operating season shall only be conducted if necessary to maintain a well-manicured appearance. INHP reserves the right to request that grass be mowed less frequently as the season starts or ends.

- B. Trimming: Contractor shall trim weeds and/or grass around all street signs, lamp posts, fences, and any other obstructions to maintain a well-manicured appearance.
- C. Bed Maintenance: The Contractor shall provide maintenance of all plant beds continuously throughout the contract period, being kept free and clear of all weeds.
- D. Trash Removal: Occasionally properties will need trash removal on properties. Please include, separately with bid, cost range of trash pick-up, if this is a service provided.

Contract Period

The initial contract period shall be from April 15, 2024, through December 31, 2024. INHP has the option to renew the contract on an annual basis for up to two additional years with the Contractor.

Personnel and Equipment

The Contractor shall designate, hire, and dismiss the personnel and provide all equipment necessary for the performance of the contract.

Insurance and Licenses

The Contractor shall maintain General Liability Insurance from an insurance company to cover bodily injury and/or property damage directly due to the negligence of the Contractor, his agents or his employees.

General Indemnity

The Contractor shall save and hold harmless, pay on behalf of, protect, defend, indemnify INHP, assume entire responsibility and liability for losses, expenses, demands and claims in connection with or arising out of any injury, or alleged injury (including death) to any person, or damage, or alleged damage, to property of INHP or others sustained or alleged to have been sustained in connection with or to have arisen out of or resulting from the performance or the intended performance of any work/service, outlined or resulting from this agreement, by the Contractor or their employees, including losses, expenses or damages sustained by INHP or INHP officials and employees from any and all such losses, expenses, damages, demands and claims. The Contractor further agrees to defend any suit or action brought against INHP or INHP officials/ employees (as outlined above) based on any such alleged injury or



damage and to pay all damages, cost and expenses in connection therewith or resulting there from. As an integral part of this agreement, the Contractor agrees to purchase and maintain, during the life of this contract, general liability insurance as outline above. The obligations of the Contractor pursuant to this paragraph shall not be limited in any way by any limitation in the amount or type of proceeds, damages, compensation, or benefits payable under any policy of insurance or self-insurance maintained by or for the use and benefit of the Contractor.

Pricing

The Contractor warrants that the pricing stated herein shall remain firm for a period of one (1) year from the first day of the contract period. Properties may be purchased and sold during the contract period. INHP will work with the vendor to establish identical pricing for single-family lots, and work with contractor on properties that are larger in size for future pricing.

Payment Terms

Payment terms are paid within 20 days following receipt of correct invoice. Invoices shall be sent via email to Jeff Howe (single family lots) and Kristin Settle (ETOD) for review and payment. Invoices MUST be submitted in excel format to be accepted.

Vendor Selection Criteria

INHP, at its sole discretion, following an objective evaluation, will award this contract to the most responsible, responsive Contractor. Bids will be evaluated using an internal evaluation process. Contract awards will be based on a combination of experience, the bidder's operational capacity, and price. The lowest price may not always receive the contract award. The final decision will be based on what is in the best interest of the organization ensure INHP that quality workmanship is performed to achieve maximum results. INHP reserves the right to make independent investigations as to the qualifications of the Contractor. Such investigations may include contacting existing customers. INHP reserves the right to accept or reject any and all proposals, and to waive any irregularities as may be permitted by law when it is deemed that such action will be in the best interest of the organization.

Proposal Information

A. Proposals will be received by INHP until March 22, 2024m at 12 p.m. Proposals may be submitted by mail, email or delivered in person. NO faxed proposals will be accepted. INHP must receive all proposals PRIOR to the date and time specified. Any proposal received after the date and time prescribed shall NOT be considered for award and the proposal shall be returned to the Contractor. Each sealed envelope containing a proposal must be plainly marked with the Contractor's Name.



- B. Each bidder must submit a proposal including:
 - 1. Total price for the performance of these services
 - 2. Completed vendor profile and certification (attached)
 - 3. Proof of General Liability insurance
 - 4. RFP Acknowledgement Form
 - 5. Proposal Form

Notification of Award

The successful Contractor will be notified in writing within ten (10) business days of this award.

Termination

Either party reserves the right to terminate the awarded contract with or without cause by notifying the other in writing 30 days prior to the termination date.
